With full knowledge of these dangers, I RELEASE the New Mexico Mountain Club and its officers, directors, members, vehicle drivers, leaders, trip participants, guides, representatives, employees or agents (collectively, the "NMMC") from liability, claims or demands and agree NOT TO SUE OR OTHERWISE MAKE ANY CLAIM against the NMMC that may arise during my participation in any activity.

This RELEASE OF LIABILITY will be effective whether or not any loss, damage, injury or death RESULTS FROM THE NEGLIGENCE of the NMMC. I understand that negligence means a failure to do an act which a reasonable careful person would do or the doing of an act which a reasonable careful person would not do under the same or similar circumstances, to protect himself, herself, or others from injury or death. I expressly assume the risk of loss, injury or death suffered by me as a result of participating in any activity. I am voluntarily participating in the activity. I am solely responsible for my own equipment, safety and first aid needs. I will take every precaution to provide for my own safety and well-being while participating in any activity.
